## **I. COMPETITION OVERVIEW**

The Orange Blossom Open will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the [current rulebook](#), and/or current Compete USA handbook as well as any pertinent updates that have been posted on the U.S. Figure Skating [website](#).

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, Learn to Skate USA® member, a collegiate club or who is an individual member in accordance with the current rulebook. For non-U.S. citizens, please refer to the [rulebook](#) for more information.

## **SOLO DANCE SERIES**

The 2024 Orange Blossom Open is a participating competition within the 2024 Solo Dance Series.

The solo pattern dance event, solo combined event and shadow dance events are being offered as part of the 2024 U.S. Figure Skating Solo Dance Series and will be conducted in accordance with the 2024 Solo Dance Series Handbook found at: [Solo Dance Series](#)

Please refer to the 2024 Solo Dance Series handbook for the current Series rules, levels and event requirements that will be in effect for this competition.

You do not need to be a registered participant in the 2024 Solo Dance Series to participate in these events: Solo Pattern Dance, Solo Combined Dance (Juvenile-Senior only) and Shadow Dance.

## **II. ELIGIBILITY**

### **Singles: Excel and Well-Balanced Events**

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
  - o Skate Up: skaters may skate up one level higher than their minimum test requirement allows.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
  - o If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
  - o If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
  - o If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate).

However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

### **All other singles and partner events (such as Adults, Pairs, Ice Dance)**

- Skaters must meet the minimum test requirements for the events level, but not exceed the maximum permissible test requirement.

## **COACHES**

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found [HERE](#). All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

With EMS, coaches must be included within a skater/team's registration or updated through their EMS Skater Portal via "[My Coaches](#)" or "Team Personnel." All coaches declared at the time of registration will be included on the registration confirmation email. Note: There is no registration approval process within EMS as the data (membership and test level) is tied to the U.S. Figure Skating database. Non-compliant coaches will receive automated email reminders through the start of the competition.

## **TEAM SERVICE PERSONNEL**

Teams are permitted a maximum of two team service personnel. Team service personnel must have a current U.S. Figure Skating membership, a green lighted background check and completed SafeSport™ Training. All compliance requirements must be met at the time of check-in to access the competition, no exceptions. Team service personnel is defined as those indicated as a team manager and/or team service personnel planning to attend the competition with the team.

## **MANDATORY ATHLETES**

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training.

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. ## **III. REGISTRATION INFORMATION**

### **ONLINE REGISTRATION VIA EMS**

Online registrations will be accepted via EMS. Payment must be made at the time of registration by credit card only. Each transaction includes a 3% transaction fee.

#### **PARTNERED EVENTS**

Only one partner will complete registration for the team. During the registration process, you will be asked to identify your partner and verify their test information. **The registered partner will be responsible for managing all aspects of the competition for the team including music/PPC upload, practice ice sales, etc.**

#### **FOREIGN SKATERS**

Non-U.S. skaters intending to register for this competition must set up a non-member account prior to registering for the competition ([click here for HOW TO](#)). This can be done by choosing the "Non-Member? Create Account" option on the [Members Only](#) login page.

#### **TEST CREDIT**

In accordance with Rules TR 3.00, 4.01 and 4.02, athletes may receive credit for meeting minimum scores at any competition held under the International Judge System (IJS). The athlete must "skate-up" to the event they are seeking test credit for, in addition to having already passed any prerequisites prior to the competition event.

How To: Skaters that meet the requirements for test credit may **request their test credit packet on EMS**. The test credit fee will be \$15 per test.

#### **CRITIQUES/FEEDBACK**

Individual critiques will be offered on a first come first serve basis. **LOC reserves the right to limit critiques based on officials' availability**. Critiques will be available for \$25 each and can be purchased in EMS.

#### **MUSIC SUBMISSION/UPLOAD**

EMS MUSIC UPLOAD: Competitors participating in events with music are required to upload their music to EMS no later than **June 26, 2024 at 11:59pm EST**. After this date, skaters will be locked out of this feature and subject to a **\$50 late fee per segment with music** (e.g. if a skater is competing in freestyle, showcase or any combined event, the skater will be subject to \$50 late fee for each event/segment that music is not uploaded by the deadline). If the skater is locked out of EMS, the skater will need to work with music coordinator to get their music submitted. The late fee, per event, will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the skater credential onsite.

#### MUSIC CRITERIA:

- File Format: MP3
- Bit Rate: 192 kbps or higher and Sample Rate: 44,100 kHz
  - This will be verified by the music chair and they may request you upload a corrected file.
- Leaders and trailers (the silence or "dead space" before and after the actual start and end of the program music) may not exceed two (2) seconds. We prefer that there be NO leaders or trailers at all. Excessive leaders and trailers may disrupt the playing of the music during competition.

Competitors must also have available a backup copy of their competition music on a cell phone and it must be immediately available rinkside whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

#### **PLANNED PROGRAM CONTENT (PPC) SUBMISSION/UPLOAD – FOR IJS EVENTS ONLY**

EMS PLANNED PROGRAM CONTENT (PPC) – Competitors participating in IJS events are required to submit PPC in EMS no later than **June 26, 2024 at 11:50pm EST**. After this date, skaters will be locked out of this feature in EMS and subject to a **\$50 late fee**. The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the skater credential onsite.

#### **REFUND POLICY**

Entry fees will not be refunded after June 16, 2024 deadline for on time entries. All late entries, if accepted, are non-refundable unless no competition exists or the event is canceled. There will be no refunds for medical withdrawals. Payment of all fees will be required before the skater is allowed to participate on the practice ice or in any event.

**The LOC and Chief Referee reserve the right to limit entries and make logistical policy modifications, both on and off ice, in response to recommended health protocols, ice availability and scheduling needs. Any cancelled events will be fully refundable except for small processing fee.**

## IV. COMPETITION DETAILS

### FACILITIES

The competition will be held at **Clearwater Ice Arena, 13940 Icot Blvd, Clearwater FL 33760**. The Rink has twin surfaces – The competition and practice ice will be hosted on the Professional Rink (North Rink) only, which measures 85'X200'. It has rounded corners and hockey barriers, 4 locker/dressing rooms and 2 party rooms, along with a Varsity Room and a large upstairs space overlooking the ice surface. The Lightning Rink, which is closest to the entrance and snack bar area may be used for events and practice sessions if schedule cannot accommodate all sessions in the Pro Rink.

### LOCKER ROOMS AND CHANGING AREAS

Locker rooms and changing areas at U.S. Figure Skating competitive events for athletes only, will be labeled with regard to specific use and where identified will be gender specific. An exception can be made for athletes under 11 years old that will allow for one parent of the same sex to assist their child immediately prior to and after their skating event(s). Please review the Locker Room and Changing Area Policy in the [SkateSafe® Handbook](#).

### U.S. FIGURE SKATING TRAVEL POLICY

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). ### OFFICIAL WEBSITE & UPDATES

It is the responsibility of each competitor, parent and coach to check the competition website and EMS frequently for any schedule changes and/or additional information pertaining to the competition.

Skaters are requested to arrive **45 minutes** prior to the scheduled time of their event.

A tentative schedule of events will be posted prior to the competition.

### SCHEDULE

The competition event times and practice ice schedule **WILL NOT** be available prior to June 30, 2024. Notification of competition and practice ice times will NOT be available by phone, mail or email.

Competitors may be scheduled on any day or time during the announced dates of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available.

EMS Competition Portal is accessible after login on members only. Skaters will be able to manage their Music and PPC, purchase of Practice Ice, viewing the Competition Schedule and updating coach information. Coaches can view their personal schedule, manage their skaters and listen to music or view entered PPC.

### PRACTICE ICE

Skaters will be able to pick their own practice ice sessions on EMS as of June 30, 2024, when the Competition schedule will also be posted. All skaters can indicate the number of sessions they want and pay for online at a cost of \$30.00 per 20 mins. After July 7, 2024, practice ice can be reserved at \$35.00

per 20 mins. Additional practice ice will be available for purchase during the competition and will cost \$35.00 on EMS. In the event that the skater is unable to use EMS to purchase practice ice, purchase may be made at Registration Desk if space is available. Practice ice fees are non-refundable.

#### ONSITE CHECK-IN

Check-in will open on **Thursday July 11, 2024 at 10:00 am**. The registration table will be open each day, one hour prior to the first event of the day, and will remain open throughout each day of the competition. Competitors need only register for their first event. Admission will be charged for spectators in excess of two persons permitted per athlete.

The registration table will be located at the entrance doors to the Pro Rink arena. To reach it, all attendees will be required to enter through the front entrance doors to the Clearwater Ice Arena.

If you are participating in a role requiring compliance, please be sure to [download or print your compliance card](#) to verify your compliance status on-site, if requested. If you believe your compliance card does not accurately reflect your compliance status, please contact [skatesafe@usfigureskating.org](mailto:skatesafe@usfigureskating.org) at least 2 business days prior to the competition for assistance.

#### AWARDS

Medals will be awarded to 1st, 2nd and 3rd place finishers in each event. Medals will be awarded to 1st, 2nd, 3rd and 4th place finishers in Compete USA events. Pick-up will be at the registration area following the posting of results for their event.

#### PHOTO/VIDEO

Individual videotaping will be permitted in designated areas ONLY. NO TRIPODS. NO FLASH PHOTOGRAPHY PLEASE.

However, Competition fees do include a video of each event the skater participates in. Video services are provided by Gabriele Photography. The videos can be accessed via a download link provided within 1 week of the competition. Family/friends will also be able to view the live stream during the event.

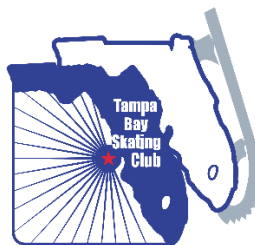
